Guidelines

Joshua Tree National Park attracts more than 2.8 million visitors each year from around the globe. They are drawn to the nearly 800,000-acre park for its magical combination of twisted geology, monolithic rock formations, unobstructed vistas, bizarre flora, and abundant wildlife. A veritable wonderland of solitude, spectacle, and cultural inspiration, the park has influenced thousands of artists to make the pilgrimage for independent residencies, brief inspirational visits, or even long-term moves.

EXHIBITION: In recognition of a long-standing tradition between artists and our national parks, in 2013 JOSHUA TREE NATIONAL PARK COUNCIL FOR THE ARTS created an annual art exposition event and juried exhibition featuring art depicting or inspired by the unique aspects of Joshua Tree National Park or its cultural history. This year's exhibition will hang at the historic 29 Palms Art Gallery at the Oasis of Mara, next to park headquarters, Sept. 1–Oct. 1, 2017, with a gala reception and awards ceremony at the gallery on Saturday, Sept. 16, 2017.

JURORS: Individuals involved in the selection process for the juried art exhibition include professional artists, photographers, art educators, art administrators, curators, art collectors, Mojave Desert and/or National Park Service representatives. (See website for Jurors for 2018.)

AWARD JUDGES: Judges for the juried exhibition awards include three arts professionals from Southern California. (See website for Judges for 2018.)

AWARDS & OPPORTUNITIES: Artists are eligible for cash awards (First \$1,500, Second \$1,250, Third \$1,000, Honorable Mention awards \$250/each). Artists' work selected for the juried exhibition will be featured in an exhibition catalogue and will be for sale during the month-long exhibition. Artists may sell additional artwork in a complimentary 10x10 booth space during exposition weekend.

ENTRY DEADLINE: Monday, June 25, 2018, by 11:59 p.m. PT.

THEME: Artwork must depict or be inspired by the unique natural aspects of Joshua Tree National Park or its cultural history.

ARTISTS: Open to living artists, working in various media, from around the world, age 18 and over.

MEDIA: Artwork(s) must be original work created by the artist within the last five (5) years and not previously submitted as an entry for a JTNP Art Exposition juried exhibition. Artwork may be:

- Painting: Oil, acrylic, watercolor, gouache.
- Works on Paper: Drawing, printmaking, computer generated art; chalk, charcoal, pastels, pencil, wax crayons; inks and washes applied by pen or brush.
- Photography: Color or black and white.
- Mixed Media: 2- and 3-dimensional works incorporating more than one type of material, including assemblage and collage.
- Sculpture: Including wood, metal, stone, glass, mosaics, ceramics, fiber, fabric, and recycled materials.

ENTRY IMAGES: Submit digital images (photos) of actual artwork(s) to be considered for the juried exhibition. **An artist may submit up to 3 works.** Only one submission (3 pieces) per artist. Submissions should be high quality (300 dpi) jpeg's, maximum 2 MB per image. Artist's LAST NAME and ARTWORK TITLE must appear on saved image files (e.g., Hilton-DesertSunrise.jpg ... *not: image001.jpg*). Do not use watermarks, copyright notices, or identification on the images. For 3-dimensional pieces, include images of all sides of the artwork.

ARTIST'S BIO: [1] Submit an artist's biography and website URL (if applicable) with the images and entry form. [2] ALSO submit a 150-word bio summary, which will be used for the artist's profile in the exhibition catalogue, if artist is selected for the juried exhibition.

ENTRY SUBMISSION: Use online entry form—www.jtnparts.org (see the Call for Art page)—or email images and artist bio to artists@jtnparts.org. Artists without access to a computer may submit entry fee, artist bio, and images on CD or thumb drive via mail to: JTNP/CA, P.O. Box 1755, Twentynine Palms, CA 92277.

RIGHTS: Copyright and all other rights to the artwork will remain with the artist. JTNP Council for the Arts reserves the right to post juried artists' artwork images and bios on its website and publish in its exhibition catalogue for the event, and use juried artists' images for publications, marketing, and event promotion purposes. Artist credit will always accompany an artist's image.

ENTRY FEE: \$35 (USD) for up to 3 images per artist. Entry fee is non-refundable and due by 11:59 p.m., June 25, 2018. Submit online payment via PayPal at: www.jtnparts.org. By mail, send \$35 check or money order payable to JTNP Council for the Arts, P.O. Box 1755, Twentynine Palms, CA 92277.

NOTIFICATION: July 2, 2018 – Artists will be notified of acceptance into juried exhibition by email or mail.

DELIVERY TO GALLERY: SHIPPED artwork for the juried exhibition is due at 29 Palms Art Gallery **between August 23 and 27, 2018**. Artists are responsible for artwork insurance and shipping costs to/from the gallery. A pre-paid return shipping label is required for shipped items and must be included in the package, or artwork could be disqualified from the exhibition. DELIVERED artwork for the juried exhibition will be received August 23 to 27 between 10 a.m. and 4 p.m., and no later than 4 p.m. Monday, Aug. 27, at 29 Palms Art Gallery, 74055 Cottonwood Drive (at National Park Dr.), Twentynine Palms, CA 92277, (760)367-7819.

SALES: A 35% commission on works sold during the show will be retained by JTNP Council for the Arts and 29 Palms Art Gallery. California sales tax will be collected by the gallery. All artwork must remain on display for the duration of the exhibition. Artists will receive payment within 30 days of close of show.

ARTIST BOOTHS: Artists selected for the juried exhibition have an opportunity to sell additional artwork in a complimentary 10x10 artist booth space at the Art Market during the Art Expo weekend Sept. 15 & 16 (10 a.m. to 4 p.m.). Artists must supply their own pop-up tent, display racks, tables, etc. The Art Market will be located on the lawn at historic 29 Palms Inn, with live music, food and beverages, nextdoor to 29 Palms Art Gallery at the Oasis of Mara. (Check "Yes" on the entry submission form, if interested.)

PICKUP/RETURN SHIPPING: Unsold artwork can be picked up at the 29 Palms Art Gallery on Sunday, Sept. 30 (3 to 5 p.m.), or Monday, Oct. 1 (10 a.m. to 4 p.m.) or other time by prior arrangement. Return shipping begins Oct. 3, 2018.

Art Market with artists' booths, music, food and beverages on the lawn at 29 Palms Inn; juried exhibition and art demonstrations at 29 Palms Art Gallery; art demonstrations at 29 Palms Creative Center; interpretive walks at the Oasis of Mara; and ranger talks at Joshua Tree National Park's Oasis Visitor Center.
